
ORDERED AND ADJUDGED that the aforesaid motion is **GRANTED** as follows:

1. This is a complex product liability and negligence action seeking damages;
2. The Petition for Authorization of Fee Contract (including attachments) and the Order thereon is confidential pursuant to Fla.R.Jud.Adm. Rule 2.420(c)(9)(A)(vii) and Florida Rule of Professional Conduct 4-1.5;

3. No parties' name is determined to be confidential;
4. The progress docket is not determined to be confidential;
5. However, the entire Petition for Authorization of Fee Contract, because it concerns a confidential and privileged document, is hereby determined to be confidential, as is the order thereon;
6. The Court finds that: (i) the degree, duration and manner of confidentiality ordered by the Court are no broader than necessary to protect the interests set forth in subdivision (c); and (ii) no less restrictive measures are available to protect the interests set forth in subdivision (c); and
7. The clerk of the court is directed to publish this order in accordance with Rule 2.42(e)(4), and to file manually and seal the Ex-Parte Petition for Authorization of Fee Contract and Order thereon dated August 12, 2024.
